A right of ingress and egress across the following described property:

All that piece, parcel or triangular parcel of land located in the County of Greenville, State of South Carolina, bounded on the west by property of Rex A. Laws and on the east by property of Grantor, and on the south by Dera Street and, according to a plat entitled Property of Rex A. Laws dated October 1, 1980, has the following metes and bounds, to-wit:
