the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

LEWIS L. BENNETT AND BETTY JO BENNETT, THEIR HEIRS AND ASSIGNS FOREVER:

ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville and being shown and designated as 4.39 acres on a plat of "Property of Lewis L. and Betty C. Bennett," prepared by John A. Simons, Registered Land Surveyor No. 2212, on February 17, 1981; and having, according to this plat, the following metes and bounds, to-wit:

BEGINNING at a nail in the center of Campbell Lake Road and running thence S. 6-12 N. 351.6 feet to an iron pin at an unnamed branch, said branch being the common line of property now or formerly owned by Maxie Wood and Mary Garrett; thence running with the meanders of said branch as follows: N. 74-37 W. 39.8 feet; S. 83-53 N. 165.0 feet; S. 58-23 N. 175.0 feet; S. 66-23 W. 157.2 feet to an iron pin; thence turning and running N. 8-55 E. 513.1 feet to a nail in the center of Campbell Lake Road; thence running down the center of said Road S. 86-17 E. 149.98 feet to the point of BEGINNING.
