ALL that certain piece, parcel or tract of land, with all improvements thereon or hereafter constructed thereon, situate and lying and being in the State of South Carolina, County of Greenville, and being shown on plat entitled "Loyd A. Smith Life Estate, Tract I" as prepared and revised by Freeland & Associates and recorded in the RMC Office for Greenville County, South Carolina in Plat Book 8M, Page 66, reference to said plat being made for a metes and bounds description thereof.

THE Grantors herein were parties to an action resulting in a Master's Deed recorded in the RMC Office for Greenville County, South Carolina in Deed Book 1133 Page 950, on September 22, 1980. Due to an error in the plat recorded and referred to in said Master's Deed, the property described in the Master's Deed was incorrect. A revised plat, being the same plat referred to above, having the proper metes and bounds has been recorded as noted above and a notation to the revised plat has been made on the Master's Deed which has been rerecorded to reflect that notation. Subsequent to the granting of the Master's Deed Loyd A. Smith died thereby vesting the remainder interest in the property described herein, if any interest did so vest, in the Grantors. This deed is being executed to convey that interest and thereby, together with the corrected Master's Deed, overcome the error of description in the originally recorded Master's Deed.

The Grantor's herein are the sole heirs of Loyd A. Smith.
