(*) Together with the right in perpetuity (insofar as the Grantor has the authority to grant such right) to use at all times in common with the Grantor and his designees, the railroad siding shown upon the plat hereinabove referred to, which railroad siding was constructed by Alwin Realty Co. and runs from a point near the westerly side of Buncomb Road in a southwesterly direction to connect with tracts of the Southern Railroad Co.; provided, however, that said railroad siding shall not be obstructed by railway cars serving the property of either the Grantee, the Grantor, or their designees, except as may be necessary in actual movement of such cars into or out of the respective premises of said parties.
