DAVID A. GREER AND PAM D. MITCHELL, their heirs and assigns forever:

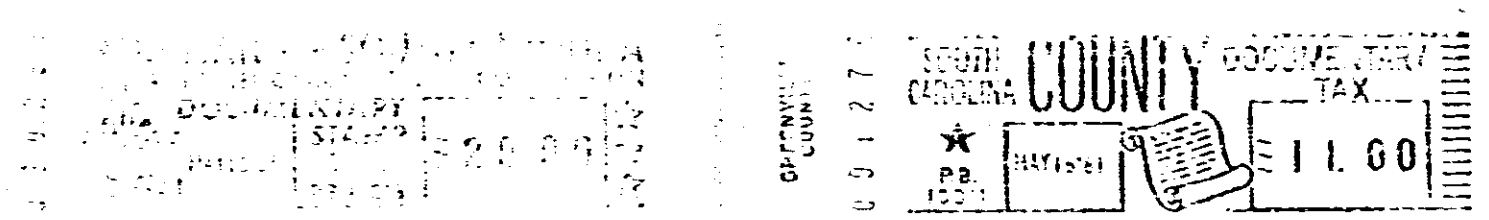
