release unto Robert Hancock and Minnie Elizabeth Hancock, their heirs and assigns,

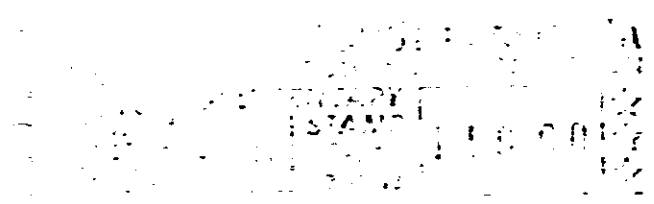
All that certain piece, parcel or unit, situate, lying and being in the State of
