Shefford St., County of Greenville, State of South Carolina, including 2,415  
feet more or less of 8" D. I. Pipe, 1,910 feet more or less of 6" D. I. Pipe,  
450 feet more or less of 2" Galv. Pipe, two 8" valves, eight 6" valves, three  
2" valves and four fire hydrants as is shown on a drawing entitled "American  
Service Corp. Greenville, S.C. to Commissioners of Public Works of the City  
of Greenville, S.C." dated December 17, 1981, attached hereto and made a part  
of this conveyance.
