ALL that piece, parcel or lot of land lying and being in the City of Greenville, County and State aforesaid and being bounded by the south side of Beattie Place, the center line of North Brown Street (closed) and the center line of Oak Street (closed), and having according to a plat prepared by W. R. Williams, R.L.S., entitled Greenville Downtown Revitalization Program, the following metes and bounds to wit:

BEGINNING at corner on Beattie Place R/W, said corner being located S67-18 E 131.09 feet, more or less, from intersection with N. Main Street R/W; thence with R/W of Beattie Place S67-18E 101.11 feet, more or less thence continuing along said R/W S74-43E 20.75 feet, more or less, to intersection with center line of N. Brown Street (closed); thence with center of N. Brown Street S29-33W 74.85 feet; more or less thence continuing along said center line S20-58W 56.8 feet, more or less, to intersection with center line of Oak Street (closed); thence with center line of Oak Street N67-31W 109.71 feet; more or less thence leaving center line of said street N20-34E 128.94 feet, more or less, to beginning.
