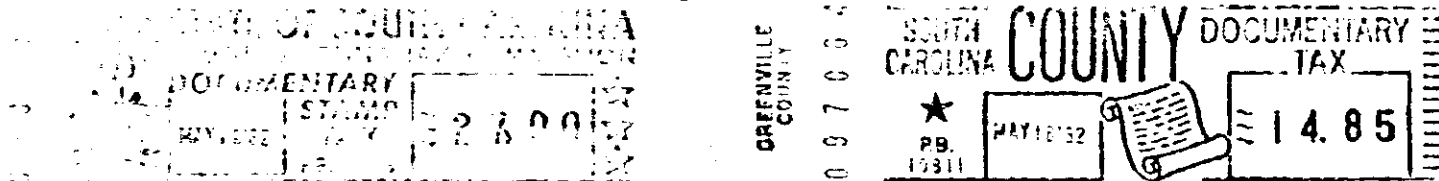

Beginning at an iron pin on the South side of Love Drive, which pin is 90 feet East side of the intersection of Love Drive and an unnamed street and running thence with Love Drive, N. 64-00 E. 100 feet to an iron pin; thence S. 25-41 W. 200 feet to an iron pin; thence S. 64-00 W. 100 feet to an iron pin; thence N. 25-41 E. 200 feet to the beginning corner.
