HOWARD, JR. in consideration of the sum of Ten Dollars (\$10.00) and other valuable considerations to the Grantors in hand paid at and before the sealing of these presents by the Grantee, the receipt of which is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto ALBERT STEVENS, his heirs and assigns forever all of the Grantors' right, title and interest in and to the following described real property:

ALL that certain piece, parcel or lot of land, together with improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville and City of Greenville, on the north side of University Ridge (formerly Elkins Street) and having, according to a survey made by C. M. Furman, Jr., Engineer, dated January 18, 1926, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of University Ridge 87 feet east of Augusta Street and at the east corner of an 8-foot alley, and at the west corner of a hedge and running thence along the north side of University Ridge, S. 79-25 E. 45.3 feet more or less to a hedge which extends from University Ridge along line of other property formerly owned by Odella Freeman; thence along said hedge, N. 13-25 E. 102.2 feet to an iron pin; thence N. 75-15 W. 69 feet to an iron pin on said 8-foot alley; thence along the east side of said 8-foot alley, S. 01-00 W. 108.9 feet to the beginning corner.

This conveyance is made subject to existing easements, restrictions, and rights of way of record.

Howard by deed of Odella Freeman dated January 25, 1935, recorded January 26, 1935 in Deed Book 171, Page 223, Greenville County RMC Office.
