This sale is subject to the following terms and conditions:

(1) As the total purchase and sales price for the above described property, the Purchasers hereby covenant and agree to pay unto the Seller the following total sum or sums which the Purchasers reserve the right to prepay in whole or in part at any time, to-wit:

The Purchasers hereby agree to pay the Seller the sum of \$ 10,000.00 as follows: \$ 2,000.00 in cash at closing, \$ 100.00 of which has already been paid and is being held in escrow by Faye Galloway Company, Sales Agent of the Seller, and the balance of the purchase price of \$ 8,000.00 to be due and payable in equal monthly installments of \$ 105.73, principal and interest, beginning one (1) month from date and continuing in a like amount each and every month thereafter until the entire principal and interest balance is paid in full. The aforementioned principal balance of \$ 8,000.00 bears interest at the rate of 10% per annum and the monthly payment of \$ 105.73 has been amortized over a ten (10) year period. All payments to be applied first to interest and balance to principal.
