and release unto Mamie L. Harley, her heirs and assigns forever;

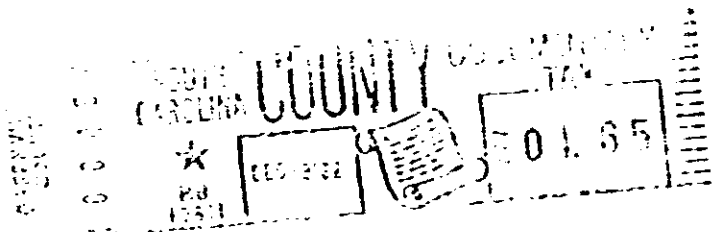
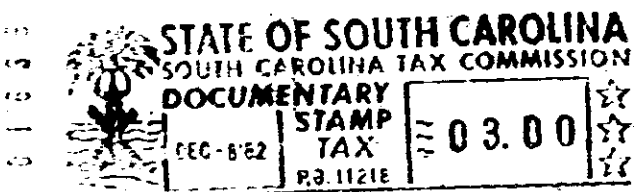
ALL that certain piece, parcel or lot of land situate, lying and being in Gantt Township,
