the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Terry L. Kitchens and Mary R. Kitchens, their heirs and assigns, forever;

ALL that piece, parcel or tract of land with all buildings and improvements thereon, situate, lying and being on the South side of Brushy Creek Road, near the City of Greenville, County of Greenville, State of South Carolina, and being known and designated as Lot No. 47 of a Subdivision known as Thornwood Acres as shown on plat thereof recorded in the RMC Office for Greenville County in Plat Book MM, at page 59, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern edge of Brushy Creek Road the joint front corner of Lots Nos. 47 and 48 and running thence along the southern edge of Brushy Creek Road, N. 53-47 West 90 feet to an iron pin; thence following the curvature Brushy Creek Road as it intersects with Drexmore Drive, the chord of which is: S. 81-10 W. 40.5 feet to an iron pin on the eastern edge of Drexmore Drive; thence along the edge of Drexmore Drive, S. 32-53 W. 100 feet to an iron pin at the corner of Lot No. 46; thence along the line of that lot, S. 57-07 E. 110 feet to an iron pin at the joint corner of Lots Nos. 46, 47, and 48; thence along the joint line of Lots Nos. 47 and 48, N. 37-37 E. 122.2 feet to the point of beginning.
