In consideration of Eleven Thousand Five Hundred and No/100 (\$11,500.00)----- Dollars,
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto James E. May, his heirs and assigns forever:

ALL that certain piece, parcel or lot of land situate, lying and being in Greenville Township (now Town of City View), Greenville County, State of South Carolina, on the northern side of Bramlett Road (formerly known as the New Cut Road), being shown as Lot "B" on plat entitled "Property of Mrs. Willie C. Williams", as recorded in the RMC Office for Greenville County, South Carolina, in Plat Book C, at Page 268B, and having the following metes and bounds, to-wit:

BEGINNING at the joint front corner of Lots "A" and "B", which point is 107 feet west of YMCA Street, and running thence with said Road, S. 84-02 W. 52.9 feet to a point, joint front corner of Lot "B" and property now or formerly of J. H. Oneal; thence with the common line of said property, N. 4-43 W. 141.3 feet to a point, joint rear corner of Lot "B" and property now or formerly of J. H. Oneal; thence, S. 89-53 E. 65.1 feet to a point, joint rear corner of Lots "A" and "B"; thence with the common line of said lots, S. 00-20 W. 134.9 feet to a point on the northern side of Bramlett Road, the point of beginning.

This conveyance is made subject to any restrictions, easements, and rights-of-way that may appear of record and/or on the recorded plat and/or on the premises.

The foregoing described real property was owned by Bates Aiken in fee during the term of his life. By the terms of the Last Will and Testament of Bates Aiken as filed in the Probate Court for Greenville County, South Carolina, in Apartment 1262, File 8, he devised to his widow, Hattie Mae H. Aiken, a one-half (1/2) undivided interest in said property, and devised to his sons, Julius B. Aiken and Harold W. Aiken, a one-fourth (1/4) undivided interest each. Thereafter, on July 6, 1973, Hattie Mae H. Aiken, conveyed her one-half (1/2) undivided interest

together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee(s)'s heirs or successors and assigns, forever. And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor(s)'s heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee(s)'s heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
