Baird Builders, Inc., its successors and assigns:

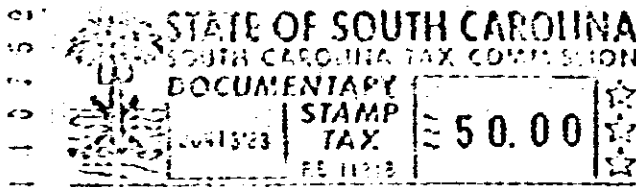
