the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto MARVIN COBURN and MARK E. COBURN, their heirs and assigns forever:

ALL that piece, parcel, or lot of land, in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lots Nos. 23, 24, and 25, of the Alex McBee Lands of Mountain City Land and Improvement Company, and having, according to a plat thereof by Dalton & Neves Co., dated April 1983, captioned "Property of Marvin Coburn and Mark E. Coburn", recorded in said R.M.C. Office for Greenville County, South Carolina, in said Book 9S, Page 6, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Hammond Street at the northeastern intersection of Hammond Street and Rhett Street, and running thence with the southeastern side of Rhett Street, N 38-22 E 223.34 feet to an iron pin; thence S 30-36 E 180 feet to an iron pin; thence S 36-31 W 202.62 feet to an iron pin in the northeastern side of Hammond Street; thence with the northeastern side of Hammond Street, N 37-34 W 179.89 feet to the point of beginning.

This property is shown on the County Auditor's Block Book as Lots 3, 4, 5, and 6, Section 3, Page 60.

Being the same conveyed to the Grantor by two deeds: (1) Lots Nos. 23 and 24, (60-3-3, 4, 5) by Violet S. Meadors, Eleanor M. Tanner, and Dorothy M. Smith, by deed dated April 27, 1973, recorded that day in said R.M.C. Office in Deeds Book 973, Page 320; and (2) Lot No. 25 (60-3-6), by James C. Thomson by deed dated May 31, 1978, recorded that day in said R.M.C. Office in Deeds Book 1080, Page 175.

The original plat is recorded in said R.M.C. Office in Deeds Book 22, Page 482, prepared by J.E. Serrine, and revised by J.R. Lawrence, April 23, 1898. This conveyance is made subject to any easements, restrictions, zoning ordinances, and rights-of-way which may affect the property.

The deed from the Grantor to the Grantees, recorded in said R.M.C. Office in Deeds Book 1187, Page 323, contained an incorrect reference to the page in the County Auditor's Block Book in which this property is shown, and this deed is executed to correct that error and to confirm and ratify the deed recorded in Deeds Book 1187, Page 323.
