II, off Highway 14, in Greenville County, State of South Carolina, including 1,510 feet, more or less, of 6" D. I. Pipe; 590 feet, more or less, of 2" Galv. Pipe; four (4) 6" valves; six (6) 2" valves; two (2) fire hydrants and ten (10) valves boxes as shown on a drawing entitled "The Fortis Corporation to Commissioners of Public Works of the City of Greenville, S.C.", dated June 9, 1983, attached hereto and made a part of this conveyance.

TOGETHER with all other mechanical parts and equipment appurtenance to the said lines and all rights-of-way and easements incident or necessary to the operation, maintenance, repair or replacement of said water lines and appurtenances.
