my Attorney in her sole discretion shall deem necessary and proper, and in my name and as my act and deed sign, seal and execute and deliver and acknowledge such deeds, leases and assignments of leases, covenants, bills, bonds, notes, receipts, evidences of debt, releases, and such other instruments in writing of whatever kind or nature as may be necessary or proper in the premises.

6. To vote at the meetings of any companies or corporations, and otherwise to act as my proxy or representative, in respect of any shares now held, or which may hereafter be acquired, by me therein, and for that purpose to sign and execute any proxies or other instruments in my name and on my behalf.

7. If I should become incapacitated or incompetent, this Power of Attorney shall not cease, but shall continue in full force and effect.

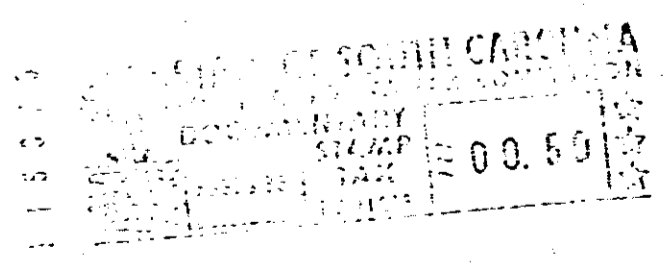
8. This Power of Attorney shall not be affected by physical disability or mental incompetence of the principal which renders the principal incapable of managing his own estate.
