Bauknight hereafter referred to as Grantee, at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the said Grantee, her heirs and assigns forever, an undivided joint interest in the following described property, so that Grantor and Grantee shall own such property as joint tenants with right of survivorship:

ALL that piece, parcel or lot of land, situate, lying and being on the easterly side of Rockingham Road, near the City of Greenville, South Carolina, being designated as Lots No. 25 and 26 on the Plat of "Barksdale" made by Dalton and Neves, Engineers, dated December 1959, and recorded in the R.M.
