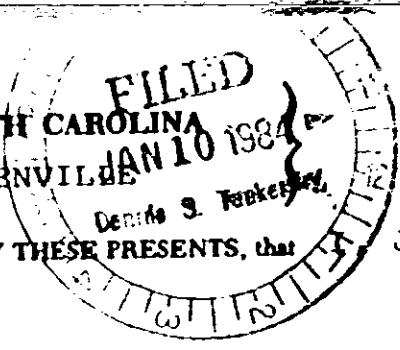

in consideration of Ten Thousand and 00/100 (\$10,000.00) ----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Linda Jean M. Lockaby, her heirs and assigns, forever:

ALL that parcel or lot of land in Chick Springs Township of Greenville County, South Carolina, located about four miles northwest of the City of Greer, lying on the west side of the Rutherford Road, being shown on a plat as part of the property of Douglas E. Greer, made by H.S. Brockman, Surveyor, December 9, 1949, and having the following courses and distances.

BEGINNING on an old stone corner, corner with lands now or formerly owned by Linda Jean M. Lockaby and W. M. Langley, and runs thence with said line of Linda Jean M. Lockaby lands N. 41-30 E. about 340 feet to a point in the center of the Old Rutherford Road; thence along and with the center line of said Old Rutherford Road, curving in a southwesterly direction to point on lands now or formerly owned by W. H. Langley; thence with said Langley line N. 36-30 W. approximately 100 feet to the beginning corner, containing one (1) acre, more or less.

ALSO, ALL that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, about four miles northwest of the City of Greer, on the west side of Rutherford Road, being shown as containing 0.92 acre on a plat of property prepared for William P. Lockaby recorded in Plat Book GGG, page 110 and according to said plat, having the following metes and bounds:

BEGINNING on an old stone corner, joint corner of land now or formerly owned by W. N. Langley, and formerly of Douglas E. Greer (now William P. Lockaby) and runs thence with the said Langley line, NM. 14-53 W. 215 feet to an iron pin on the said line, new corner; thence a new line, N. 66-40 E. 283 feet to a nail and cap in the center of the said Rutherford Road (iron pin back on line at 28 feet); thence with the said road S. 19-18 E. 69 feet to a point in the said road, and on the former Douglas E. Greer line, now joint corner of the William P. Lockaby line; (continued on back)
