ALL that certain piece, parcel or lot of land situate, lying and being on the Southern side of S. Pliney Circle in the Town of Simpsonville, County of Greenville, State of South Carolina, and being known and designated as a portion of Lot #33 on plat of League Estates, and having according to a recent survey by Webb Surveying and Mapping Company, dated September 6, 1966, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southern side of S. Pliney Circle at the joint front corner of Lot #33 and 34 and running thence along said S. Pliney Circle, N. 59-30 E. 88 feet to an iron pin, thence on a new line through Lot #33, S. 23-20 E. 162 feet to an iron pin, then S. 55-26 W. 98.6 feet to an iron pin at the joint rear corner of Lots #33 and 34; thence with the common line of said Lots, S. 2-00 W. 170.1 feet to the beginning corner.
