in consideration of Eight Thousand and no/100ths (\$8,000.00) ----- Dollars,

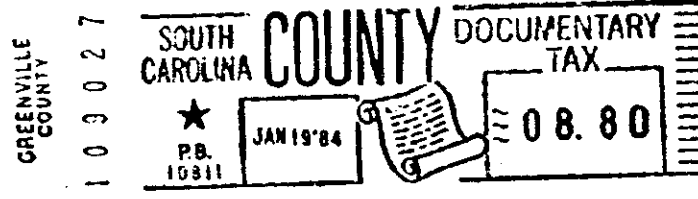
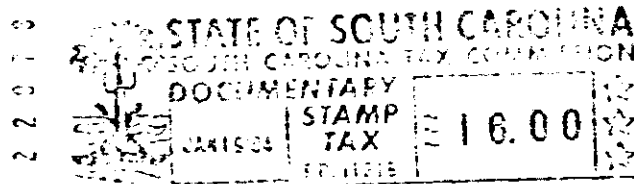
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Claude Thompson and Mary Thompson, their heirs and assigns forever:

ALL that certain piece, parcel or lot of land lying being in the Fairview Township, County and State aforesaid, located on the Southwest side of Cox Street near near the town of Simpsonville, being shown as a portion of Lot No. 3 of a plat made by E.E. Gary, Surveyor on November 26, 1948, and more fully described as follows:

BEGINNING at an iron pin on Cox Street, joint front corner of lands now or formerly of Medlock, and thence running along Cox Street S. 73 1/2 E. 90 feet to an iron pin on Cox Street, joint front corner with lot No. 2; thence along line of lot No. 2, S. 1 1/2 W. 122 feet to an iron pin on the joint lot line of Lot No. 2; thence turning to a point on the joint lot line now or formerly of Medlock and the joint line of Lot No. 4 146 feet from the iron pin on Cox Street; thence running along the Medlock line N. 1 1/2 E. 146 feet to Cox Street and the point of the beginning.
