Walter Brashier to Commissioners of Public Works of the City of Greenville, S. C.", dated March 20, 1984, attached hereto and made a part hereof for the purpose of reading, operating, maintaining, replacing and adding to the water meters and other appurtenances thereto located on the property of the Grantor.

IT BEING understood that the water mains located in and serving Rutherford Place and being on the property of the Grantor shall and do remain the property of the Grantor and the Grantor shall be fully responsible for the maintenance thereof.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor(s)' heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee(s)' heirs or successors and assigns against the grantor(s) and the grantor(s)' heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
