All that piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville on the eastern side of McElhaney Road, being shown and designated as Lot No. 115 as shown on a Plat of Green Valley Estates, prepared by Piedmont Engineers Service dated December 20, 1957, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book QQ, Pages 2 and 3 and having, according to said plat, the following metes and bounds:

Beginning at a point on the eastern side of McElhaney Road at the joint corner of Lots Nos. 115 and 116, and running thence along McElhaney Road with the line of Lot No. 115 N. 10-34 W., a distance of 119.1 feet to a point; thence continuing along McElhaney Road with the line of Lot No. 115 N. 9-33 W., a distance of 172.1 feet to the joint corner of Lots Nos. 114 and 115; thence running along this joint boundary line in an easterly direction S. 77-36 E., a distance of 361.0 feet to a joint corner of Lot Nos. 114 and 115; thence running along West Round Hill Road of Lot 115 S. 7-16 W., a distance of 100.0 feet to a point; thence continuing along West Round Hill Road with the line of Lot No. 115 S. 4-46 E., a distance of 100.0 feet to the joint corner of Lots Nos. 115 and 116; thence running along the common boundary of line of Lots Nos. 115 and 116 S. 87-32 W. a distance of 299.2 feet to the point of beginning.
