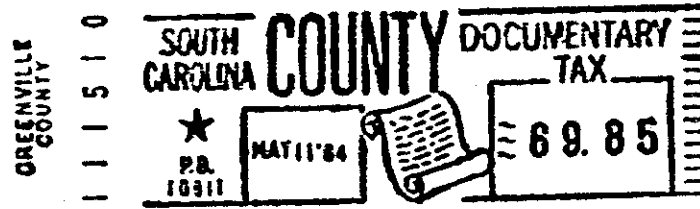
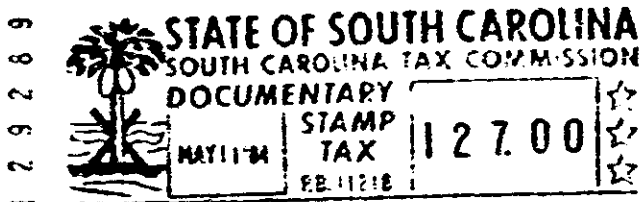
KNOW ALL MEN BY THESE PRESENTS, that **Foothills Delta P, Inc.**
