the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto HEYWARD R. McCONNELL, his heirs and assigns forever:

ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, within the corporate limits of the City of Greenville, and being that portion of Lots 35 and 36 which lies south of a branch that intersects said Lots 35 and 36 according to a plat recorded in the RMC Office for Greenville County in Plat Book A at Page 225, and having the following metes and bounds, to-wit:

BEGINNING at a point where the joint line of Lots 36 and 37 meet at line of property now or formerly of Houston & Company and running thence along the line of that property N. 82 W. 100 feet to a point; thence with the joint line of Lots 34 and 34, N. 1-30 W. to the above-mentioned branch; thence with the above-mentioned branch, in an easterly direction, approximately 100 feet to a point in the joint line of Lots 36 and 37; thence with the joint line of Lots 36 and 37, S. 1-30 E. to the point of beginning.
