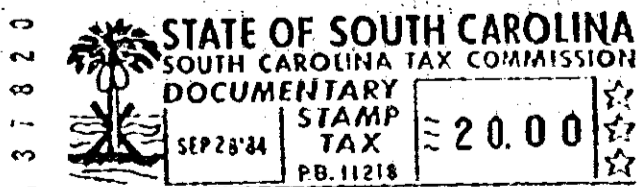
HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said Dawson W. Dill:
