WHEREAS, Woven Electronics Corporation, the sole adjacent property owner on both sides of Evans Street and a portion of West 9th Street in the Town of City View, Greenville County, S.C. has requested that the Town of City View close Evans Street between Bramlett Road and West 9th Street and so much of West 9th Street as is marked in red on the plat attached hereto and incorporated herein by reference in order to avoid a dangerous traffic situation at the intersection of Evans Street and West 9th Street and to provide additional security for Woven Electronics Corporation; and WHEREAS, the closing of such streets will in no way affect the ingress and egress of property owners abutting the unclosed section of Evans Street or any other property owners in the Town of City View.

NOW THEREFORE, Know All Men By These Presents:

That the Town of City View hereafter referred to as Grantor, in consideration of the sum of One Dollar (\$1.00) DOLLARS, paid to Grantor by Woven Electronics Corporation hereafter referred to as Grantee, at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the said Grantee all its right, title and interest in that portion of land lying in Evans Street between Bramlett Road and West 9th Street and that portion of West 9th Street 167 feet long, more or less, from the center line of the intersection of Evans Street and West 9th Street all as marked in red on the survey for Woven Electronics Corporation prepared by W. R. Williams, Jr., dated June 1, 1982 and attached hereto and incorporated herein by reference.
