(hereinafter called "Grantee") in the State aforesaid, (the receipt of which is hereby acknowledged)
has granted, bargained, sold and released, and by these Presents does grant, bargain, sell and release,
unto the Grantee, his heirs, successors and assigns:

ALL that certain piece, parcel or lot of land, being and situate in
the County of Greenville, Cleveland Township, and the State of South
Carolina, and being shown and designated as a 12.34 acre tract on a
plat entitled "Property of Kermit T. Gould, Sr." prepared by Kermit T.
Gould SCRLS #4035, dated January 26, 1983, recorded in Plat Book 10-2
at page 33 in the RMC Office for Greenville County and having,
according to said plat, the following metes and bounds to wit:

BEGINNING at a point in the center of Persimmon Ridge Road, 1 1/2 miles E.
of US Highway 276, and at the southwest corner of said tract and
