KNOW ALL MEN BY THESE PRESENTS, That Kermit T. Gould, Sr.,
(hereinafter called "Grantor"), for and in consideration of the sum of One (\$1.00)

to the Grantor in hand paid at and before the sealing of these presents, by - - -
Nancy Diane Gould of Greenville, South Carolina

(hereinafter called "Grantee") in the State aforesaid, (the receipt of which is hereby acknowledged)
has granted, bargained, sold and released, and by these Presents does grant, bargain, sell and release,
unto the Grantee, his heirs, successors and assigns:

ALL that certain piece, parcel or lot of land, being and situate in the
County of Greenville, Cleveland Township, and the State of South
Carolina, and being shown and designated as a 10.35 acre tract on a
plat entitled "Property of Kermit T. Gould, Sr." prepared by Kermit T.
Gould SCRLS #4035, dated January 26, 1983 and recorded in Plat Book
10-Z at page 33 in the RMC Office for Greenville County and having,
according to said plat, the following metes and bounds to wit:

BEGINNING at a point in the center of Persimmon Ridge Road, 1½ miles E.
of US Highway 276, and at the southwestern corner of said tract and
running thence N. 33-54 W., 1043 feet to an iron pin; thence N. 80-37
E., 569.58 feet to an iron pin; thence S. 32-11 E., 809.46 feet to an
iron pin ; thence S. 23-21 E., 25 feet to an iron pin in the center of
Persimmon Ridge Road; thence following the midline of said road to the
point of beginning. Said property being bordered on the west by a
12.35 acre tract being the property of Joan W. Gould, and bordered on
the east by a 10.55 acre tract being the property of Kermit Taylor
Gould, Jr.,
