 Land So. 49 W. 34. 50. to a Rock 3<sup>d</sup> new on the Ridge Road thence do  
 -wn the meander of said Road to a chestnut corner new on John Ma-  
 haffys Sr. line thence with S<sup>d</sup> line N. 2. 3. E. 30. chains to a Stake 3<sup>d</sup>
