 aforesaid on the branches of the North fork Saluda River and runs or follows
 that is to say beginning on a Hickory thence ~~south~~ N 8 to a pine thence S 15
 N 9 to a stake on stanfords line thence with said stanfords line to a small
 branch that runs through William Sheltons field thence up said branch
 to the fork thereof thence up the west or left hand fork to the head in
 an old field thence up hollow to a stake on the Ridg thence down the
 Hollow over the Ridg a Northwardly course to the head of a small
 Branch thence down said Branch to a conditional marked line orig-
 inally made between Marson and Albert Smith thence with said cond-
 itional to the Beginning being part of a large survey granted to Rob-
 ert Prince by a grant bearing date the seventh day of March one thou-
 sand seven hundred and Eighty seven Together with all and singular the
 Rights members hereditaments and appurtenances to the said Premises
 Belonging or in anywise incident or appertaining To have and to
 hold all and singular the premises above mentioned unto the said Philip
