 of twenty one dollars to each of us in hand paid or caused to be paid  
 by Charles Sotherland of Greenville District and State of South Carolina  
 the receipt whereof we and each of us do acknowledge Have granted  
 Bargained sold, released conveyed and confirmed and by these presents do  
 Grant bargain sell release convey and confirm unto the said Charles Sotherland  
 his heirs and assigns two fifth parts of all that plantation tract or parcel  
 of land containing one hundred acres be the same more or less situated  
 in Greenville District aforesaid on a branch of the North fork of Sa-  
 luda River originally granted to Benjamin Barton by grant be-  
 -aring date the sixth day of February one thousand seven hundred and  
 -eighty six and by Barton was conveyed to our second father Fran-  
 -cis Holley under whom we claim as legatees the said tract of land  
 runs or follows that is to say beginning on a cherry nut thence E. forty  
 Chains to a Hickory thence North sixteen chains to a Hickory thence  
 North six degrees west forty Chains to a cherry nut thence South nine  
 degrees west thirty seven Chains to the beginning the whole tract being one  
 hundred acres more or less as aforesaid two fifth part of which we  
 here by convey as aforesaid Together with all and singular the Rights  
 number hindelamments and appertinances to the said premises, belonging  
 or in any wise incident or appertaining to have and to hold  
 all and singular the said two fifth parts of the said premises unto  
 the said Charles Sotherland his heirs and assigns for ever and we do  
 hereby for our selves our heirs Executors and administrators jointly and  
 severally bind our selves so warrant and for ever defend the above men-  
 -tioned premises unto the said Charles Sotherland his heirs and assigns  
 against our selves our heirs Executors and administrators and against  
 every other person or persons whomsoever lawfully claiming or  
 to claim the same or any part thereof In witness whereof  
 we have hereunto set our hands and seals this 14 day of Febru-
