 Send greeting Whereas by virtue of a writ of fieri facias issued out
 of the Court of Common Pleas held for the District of Greenville
 Tested the nineteenth day of April in the year of our Lord one thousand
 Eight hundred and twenty four at the suit of Hiram Whitted
 Administrator to me directed commanding me that of the goods and
 Chattles lands and Tenements of Jesse Green to Levy the Sum of
 Eighty two Dollars three & three fourths damages and costs I have
 Seized and taken of the lands and tenements of the said Jesse Green
 All that certain piece parcel and tract of land containing one
 Hundred & fifty Acres more or less situate and being in the District
 of Greenville on the waters of North Saluda bounded on one
 Side by Thobbs narrow Henry Rays Land John Edwards Land George
 Salmon it being the tract William Johnson sold to Hanciniah
 Ray, which tract, was conveyed to William Johnson by William
 Gamelle and whereas the said premises with their appurtenances
 since the seizure by me made by virtue of the said writ of fieri
 facias before mentioned have been exposed to sale at public vendue
 and purchased by John Chiles of the District of Greenville State
 aforesaid for the sum thirty one dollars & fifty cents being the
 Highest sum that was bid therefor Now know ye that I Nimrod
 Underwood Sheriff aforesaid by virtue of the said writ of fieri
 facias aforesaid to me directed and delivered as aforesaid and by
 virtue of the statute in such case made and provided, and for and
 in consideration of the said sum of thirty one dollars & fifty cents
 to me in hand paid or secured to be paid by the said John Chiles
 The receipt and payment whereof I do hereby acknowledge, have
 Granted bargained and sold and by these presents do Grant bargain
 and sell unto the said John Chiles his heirs and assigns for ever
 The said tract piece and parcel of land with its appurtenances and
 all the Estate rights titles and interest which the said Jesse Green of
 Right had of in and to the same to have and to hold the said piece
 Parcel and tract of land with its appurtenances unto the said John
 Chiles his heirs and assigns for ever as fully and absolutely as I
 The said Nimrod Underwood might could or ought to Grant bar-
 gain and sell the same by virtue of the statute aforesaid and the
 said writ of fieri facias or other wise in witness whereof I the
 said Nimrod Underwood have unto set my hand and seal the
