 South Carolina Greenville Dist. Personally came before me
 Thomas P. Hudson & made oath as the law directs & saith upon
 Oath that he saw Israel Miller senr. sign seal & deliver this
 deed of conveyance unto George Green for the contents there
 in mentioned & that Israel Miller was a concurring witness
 with himself sworn to and subscribed before me this 23rd

 George Green all that tract or parcel of land containing
 Sixty six Acres more or less being part of a tract of
 Land containing two hundred and seventeen acres
 originally granted unto Gray Russell on the third day
 of May anno domini one thousand seven hundred
 Ninety lying and being in Greenville District in the State
 aforesaid on both sides of Hempes Branch of Enoree River
 and bounded as follows Beginning on a post oak corner
 Dawn running thence N. 85. 10. twenty nine chains 50 links
 to a red oak corner thence 80 nine ten West thirty four
 chains to a post oak corner thence South 66 East thirty
