State of Carolina Greenville District, Know all men by these Presents that I Elizabeth Pace and Benjamin Malin of the State and district aforesaid for and in consideration of the sum of Five Pounds Sterling money to us in hand paid at and before the signing and delivery of these Presents the receipt whereof is hereby acknowledged have bargained and sold and by these Presents do bargain grant and will James Goodlett of the State of Georgia South Carolina District his heirs and assigns a certain tract or parcel of Land situate in the State and district aforesaid on the waters of Syger River containing two acres more or less on the North Side of the Sugar road adjoining Land now belonging to said James Goodlett running along near said Goodlett's house the road one line on the South side it being part of a tract of Land belonging to John Malin deceased, So have and to hold unto the said James Goodlett his heirs and assigns to have and to hold the said Land and premises from the said Elizabeth Pace and Benjamin Malin their heirs and assigns forever and from all and every other person or persons lawfully claiming the same or any part thereof, in witness whereof we have hereunto set our hands and Seal, this 18th day of October one thousand eight hundred and twenty five in presence of us. -
