

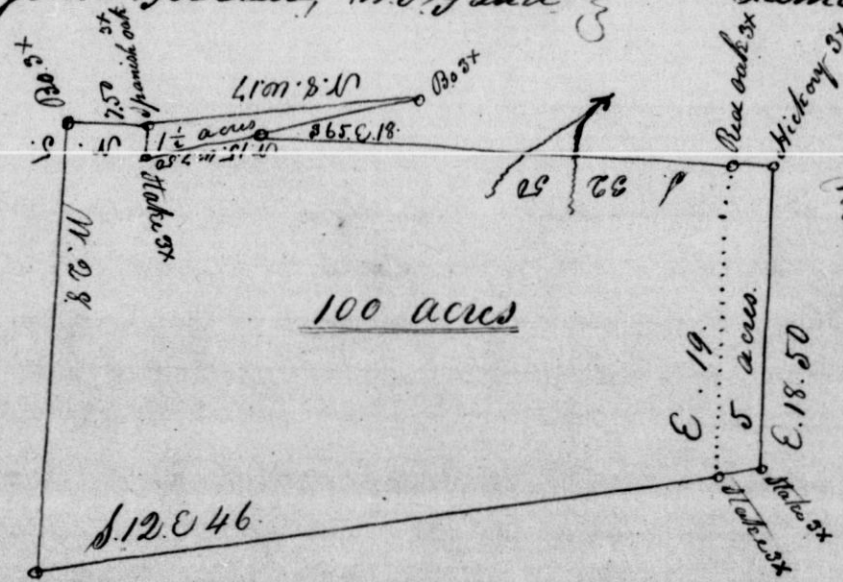

And I the said Thomas Crofford do for my self my heirs Executors and administrators covenant to and with the said Rich and Gantt his heirs and assigns that I am lawfully seized in fee of all and singular the before mentioned Tracts or parcels of land and every part and parcel thereof and that the said Gantt his heirs and assigns shall enjoy the same without the least hindrance or molestation of any person or persons whomsoever claiming title thereto or any part thereof and that the said Thomas Crofford doth further for my self my heirs Executors and administrators warrant and for ever defend unto the said Richard Gantt his heirs and assigns all and every the foregoing premises and every part and parcel thereof free from the Claimes of me and my Heirs and all and every person or persons whomsoever - In testimony whereof I have hereunto set my hand and affixed my seal this 7<sup>th</sup> day of March anno Domini 1826 signed sealed & delivered in presence of

Gantt personally appeared William J. Gantt before me the subscribing Justice Greenville District and made oath that he saw Thomas Crofford sign seal and acknowledge the within deed of Conveyance to Richard Gantt for the uses and purposes therein mentioned and that John Gordon was subscribing to the Execution of the same - Sworn to before me on the 24 day of October A.D. 1826.

It is understood between the said Crofford and Gantt parties to the foregoing deed that five acres as represented in the annexed plat of land from Samuel to Thomas Crofford had been exchanged by Thomas Crofford with John Townes for the one and a half acre mentioned in the within deed and the said Crofford for himself and his heirs Executors and administrators warrants to said Gantt his heirs and assigns the full complement of one hundred and nine or ten acres of land after deducting the said five acres above mentioned signed sealed and executed as a part of the foregoing deed at the time of the delivery of said deed on the 7<sup>th</sup> March 1826.
