 tract or parcel of land conveyed by Polly Jenkins to me situate lying  
 and being in the district and State aforesaid on the Northern side  
 of a Road leading from Rally or rather now held by Owen & Vincent  
 Jenkins a Mill to Capt. Thomas Springfields and on the South side of  
 Enoree River Beginning on a red Oak corner on the side of the said  
 Road at the head of a small Valley thence Northwardly a conditional  
 line to a Heckery 3x on Samuel Styles' line thence Northwardly an an open  
 line binding on sd. Styles line to Black Jack 3x thence Southwardly on Styles  
 & Elisha Gunn line to a red Oak 3x or to the said Road before mentioned  
 thence down the said Road to the head of the Valley the beginning corner  
 stand in to a Stake 3x thence to the beginning altogether supposed to conta  
 in One hundred Acres better or less. Also a tract parcel of  
 land conveyed by Samuel Styles to my self supposed to contain twenty five acres  
 be the same more or less Beginning on a Red oak 3x on sd Langford line Below  
 his shop and Enoree River thence Northwardly to a Red Oak 3x on the South bank  
 of the sd. Enoree River thence down the defficient meanders of the River to Polly  
 Jenkins line thence Southwardly on sd line to a red Oak 3x on Jenkins, Styles &
