Archer Holcomb in consideration of two hundred and forty dollars to me paid John Lucas of said district I have granted bargained sold and released by these presents do grant bargain sell and release unto the said John Lucas a plantation or tract of land lying & being in Greenville district on the head of Packer Creek of South Syger River joining land surveyed for Reuben Barrett on one side. beginning an oak corner running N. 70. E. 35 to a post oak thence S. 20. E. a conditional corner on the branch thence down the sd Branch to a conditional corner on a up thence a Strait line to one more conditional corner on a post oak on the other line thence N. 20. W. to the beginning corner on the red oak the same being a part of a tract of land granted to Shadrach Henry & by the sd Henry sold & conveyed unto the sd Solomon Loftis and by the said Labon Loftis this part sold and conveyed unto the sd Holcomb. Containing by Estimation one hundred acres be the same more or less I'm proving the Improvement whereon the sd Holcomb know lives together with all and singular the rights members hereditaments and appertinances to the sd premises Beginning or in anywise appertaining to have and to hold all and singular the said premises before mentioned unto the John Lucas his heirs and assigns for ever & do here by bind my self my heirs and Executors and administrators to warrant and for ever defend all all and singular the sd premises unto the sd John Lucas his heirs and assigns against myself and my heirs and against all & every other person whomsoever lawfully claiming or to claim the same or any part thereof. In witness whereof I the sd Archer Holcomb have hereunto set my hand and affixed my seal the 20th of March one thousand Eight hundred nine and in the thirty fourth year of American Independence signed sealed & delivered in presence of us the witnesses the above date set Wm.
