 corner on the South side of the River thence up the River on the same
 side to a conditional Maple corner thence across the River on a conditional
 Blazed line to a conditional Spanish Oak corner thence to a conditional
 Chopt line to a conditional poplar corner on the branch the same bei-
 ng a conditional line between myself and Alexander Keller thence down
 the meanders of said branch a south west direction to a Hickory corner on
 Thomas Barton line thence south 84.9 ch. 50. lks to a chestnut corner thence south
 74. 1/2 with Bartons line 6 ch. 50. lks to a black gum corner crossing the creek thence
 80.70. w. 27. ch to a small Red oak corner Bartons South corner thence 80.29 ch
 to a black oak corner thence E. 72 ch 52 links to a white oak corner thence
 North thence on David Mastellers line to the beginning white oak corner
 supposed to contain two hundred and fifty acres be the same more or
 less it being the South West end of a tract of land granted to Edmond
 Bearden on the fifteenth of December 1784 and by him conveyed to John
