Road leading from Capt. Gums to Pike's Mountain and running S 8
E. 33. 80. to a Chesnut corner thence S 54. E 24. links to a Spanish Oak cor-
ner thence N. 80. W. 55. Chains to a Chesnut corner near the said road
thence to the beginning; and also one other tract adjoining the above
on the north side containing five acres be the same more or less
beginning at a Red oak near a Spring and running S. 80. 13 E. 90 links
crossing a branch to a white oak thence N. 10. E. 3. 60. to a stake by a hick-
-ory thence N. 80. W. crossing the Spring branch 13. 90 to a stake thence S 10
W. 3 Ch. 60 links to the beginning making in both tracts, be the same more
or less fifty acres Together with all and singular the Rights, number
rights, tenements and appurtenances to the said premises belonging or
