 This Indenture, made this sixteenth day of July in the year of our Lord one thousand eight hundred and thirty one Between Rolly Jenkins of the District of Greenville in the State of South Carolina and Susanna Jenkins his wife, of the first part; and Hardy J. Gilreath, Rolly Jenkins Owen Jenkins, Vincent Jenkins, Jeph Satterfield, Robt. Nelson Thos Springfield & Westly Gilreath, Trustees of the Methodist Epis Church in all of the District of Greenville in the State of South Carolina aforesaid, of the second part. Witnesseth, That the said parties of the first part, for and in consideration of the sum of one hundred dollars lawful money of the United States of America, to them in hand paid at and upon the sealing and delivery of these presents, the receipt whereof is hereby acknowledged have given, granted, bargained, sold, released, confirmed and conveyed, and by these presents do give, grant, bargain, sell, release, confirm and convey unto them the said parties of the second part, Trustees as aforesaid and to their successors in office, in trust for the uses and purposes hereinafter mentioned and declared, all the estate right, title, interest, property, claim and demand whatsoever, either in law or Equity which the said parties of the first part have in, to or upon all and singular a certain lot or piece of land, situate lying and being in the District of Greenville and State aforesaid, bounded as follows Beginning on a stake on Isaac Chandlers line running thence North 88 3/4 E. 5 chains to a stake 3x Joining land land to Owen & Vincent Jenkins thence S 7 1/2 E. 8 chains to a stake near the Road leading to McElhany's ford thence along the road to a red oak on Isaac Chandlers line thence along said Chandlers line N. 8. 80 chains to the place of beginning, containing and laid out for five and one third acres of land. Together with all and singular the houses woods, waters ways, privileges and appurtenances thereto belonging or in any wise pertaining. To have and hold all and singular the above mentioned and described lot or piece of land situate, lying and being as aforesaid, together with all and singular the houses, woods, ways, waters and privileges, thereto belonging, or in any wise appertaining, unto them the said
