shall come I James McDaniel Esq Sheriff of the district  
and State aforesaid send greeting whereas by virtue of  
of a writ of Fieri Facias to me directed & issued by the Tax  
Collector of the said district of Greenville tested the  
9<sup>th</sup> of June Eighteen hundred and thirty at the suit of  
the State of South Carolina for Taxes which said (Deft)  
Refused Payment to me directed & commanded me that of  
the Goods and Chattels Lands and Tenements of Elizabeth  
Standford to Levy the sum of four dollars and Twenty Eight  
Cents with Costs and Charges I have seized and taken  
of the Lands and Tenements of the said Elizabeth Standford  
all that certain piece Parcel and tract of Land con-  
taining one hundred acres be the same more or less  
for the space of Seven years only from the second  
day of February 1832 at which time this Lease or deed  
is out and has no Bearing on said Land and said Land  
falls to the original owner at that time situate  
Lying and being in the district of Greenville and  
State aforesaid on the waters of Tyger adjoining of  
Benjamin Lynch and others and whereas the said  
premises with their appurtenances since the seizure  
by me made by virtue of the said writ of Fieri Facias  
before mentioned have Exposed to Sale at Public Vendue  
and Purchased by Benjamin Lynch of the district  
and State aforesaid for the sum of Eight dollars  
being the highest sum that was Bidden therefor  
now know ye that I James McDaniel Sheriff as a  
foresaid by virtue of the said writ of Fieri Facias afo-  
said to me directed and Delivered as aforesaid and by  
virtue of the Statute in such Cases made and Provided  
and for unconconsideration of the sum of Eight dollars  
to me in hand Paid or Secured to be paid by the said  
Benjamin Lynch the Receipt and payment I do  
hereby acknowledge have Granted Bargained Sold and  
and by these presents do Grant Bargain and Sell unto  
the said Benjamin Lynch his heirs and assigns for  
Ever the said piece Parcel and tract of Land for the  
Term of Seven years as above stated with its appurten-  
ances and all the Estate Right title and Interest which  
the said Elizabeth Standford of Right had of in and to  
the same to have and to hold the said piece Parcel and  
tract of Land as above stated his heirs and assigns as  
fully and absolutely as I the said James McDaniel  
Sheriff could or ought to Grant Bargain and Sell the  
same by virtue of the Statute aforesaid and the  
said writ of Fieri Facias or otherwise in Witness  
whereof I the said James McDaniel Sheriff as a  
foresaid have hereunto set my hand and affixed my
