on a conditional line made between Moses Batson and Lewis Batson
thence said conditional line to a branch thence said branch to the
Beginning together with all and Singular the rights titles profits and
Hereditaments Incident or any wise appertaining to said fifty
acres more or less and further the said George Cornett does Covenant
with the Miles Gayles and does warrant and forever defend the above
premises aforesaid from himself his heirs Executors and every other person
or persons lawfully claiming or to claim the same or any part thereof
to the said Miles Gayles and his heirs and assigns forever in witness
whereof I have set my hand and Seal this 2nd day of March 1832
