 corner the other tract of land also lying in the State and district  
 aforesaid on the Saludia Mountain on the North fork of fall  
 creek Beginning at a stake on Jords line Running to a conditional  
 line made between Eli Sankford and John Corbin thence to a  
 conditional line made between Thomas Morgan and John Corbin  
 from thence to the Back line and thence to the beginning contain-
