Blasingame Sheriff of Greenville district and State aforesaid send
Greeting Whereas by virtue of writ of fieri facias issued out of the Court
of Common Pleas held for the district of Greenville tenth the third day
of October in the year of our Lord one thousand eight hundred and
thirty one at the Suit of John Watson ordinary to me directed Comon-
-anding me that of the Goods and Chattels Lands and tenements of
John Whitten to levy the sum of five thousand dollars and upwards
Damages and Costs I have seized and taken of the lands and tenem-
-ents of the said John Whitten all that certain piece parcel &
tract of land containing four hundred acres more or less situated
and being in the district of Greenville on both sides of South Pacolet
River whereon the said John Whitten now lives bounded on the South by
Lands of Capt. M. Rush on the East and north East B. Wilkenson Theron
Earle & George Beck and on the West by Silas R. Whitten and on the
West by David McDavis and whereas the said premises with their apper-
-tainances since the seizure by me made by virtue of the said writ of
fieri facias before mentioned have been exposed to sale at Public Vendue
and purchased by Silas R. Whitten of the district aforesaid for the sum of
Sixteen hundred dollars being the highest sum that was bidden therefor now
know ye that I William Blasingame Sheriff aforesaid by virtue of the
said writ of fieri facias aforesaid to me directed and delivered as aforesaid
and by virtue of the Statute in such case made and provided and for
and in consideration of the said sum of sixteen hundred dollars to me
in hand paid or secured to be paid by the said Silas R. Whitten the
Receipt and payment whereof I do hereby acknowledge have granted
Bargained and sold and by these presents do Grant Bargain and sell unto
the said Silas R. Whitten his heirs and assigns forever the said tract piece
and parcel of land with its appertinances and all the Estate right
title and Interest which the said John Whitten of right had of in and
to the same to have and to hold the said piece parcel and tract of
land with its appertinances unto the said Silas R. Whitten his
heirs and assigns forever as fully and absolutely as I the said William
