 Greenville District } Thruston of the State and district before mentioned  
 in consideration of the sum of eight hundred dollars to me in hand paid by Zerah  
 Davis of the State and district aforesaid have bargained and sold and by these  
 presents do Grant Bargain and sell and release unto the Said Zerah Davis all that  
 tract or parcel of land whereon the Said Davis lives containing five hundred acres  
 more or less lying in the above mentioned district on the West Side of Zedy  
 River Beginning on a gum corner made between William Thruston Sr. and Richd  
 Thruston while the Said land was in his possession thence with the Said William  
 Thrustons line to a pine corner thence with the Said William Thrustons line to a  
 white oak corner at the ford of the Branch thence a straight line to a white oak  
 at the corner of Said William Thruston apple orchard and thence Westwardly  
 a straight line to the Branch between the Said Richard Thruston and Reubin  
 Martin thence down Said Branch to Sydney Bradleys line thence with Said  
 Bradleys line to the old road leading to Abraham Bradleys do place thence with  
 Said road to a stake corner on the top of the hill thence with Said Sydney  
 Bradleys line to Isaac Bradleys line thence with Said Isaac Bradleys line  
 to a Hickory corner on the Branch thence up Said Branch with the Branch to  
 a corner made between the Said Richard Thruston and the Said Isaac Brady  
 thence Square across to the main Road through the middle of a pond to a stake  
 on the road thence up Said Road to Charles Bensons line thence with Said  
 Bensons line to a post oak corner on Said Bensons line thence with Said  
 Bensons line to an apple corner on the river thence up Said River keeping
