to a chestnut thence N 60 E 45 to a chestnut oak thence N 34 W 57.50 to a black
Gum thence to the Beginning Together with all and Singular the rights members
Hereditaments and appertinances to the Said land belonging or in any wise
Incident or appertaining to have and to hold all and Singular the premises
before mentioned unto the Said Hartwell Richards his heirs and assigns forever
and I do hereby bind myself my heirs Executors and administrators to
Warrant and forever defend all and Singular the Said premises unto the
Said Hartwell Richards his heirs and assigns against myself my heirs and
against Every person lawfully claiming all or any part thereof Witness
my hand and Seal this 24th December A.D. 1833
