

for said the following negro Slaves (Viz) I Saac a carpenter Lucy Emily George Edward Jane William all of one family also Maria Cheney John Swannah maria Margarett Caroline Galitha Charles Hamburg and Cheney to have and to hold the said negro Slaves I Saac Lucy Emily George Edward James William Maria Cheney John Susan maria Margarett Caroline Galitha Charles Hamburg Cheney unto the said John Robinson and James K Robinson their Executors administrators and assigns forever provided always &c &c that if the said Jully H Sullivan his heirs Executors administrators or assigns shall and do Well and truly pay or Cause to be paid unto the said John Robinson and James K Robinson their certain attorney Executors administrators or assigns the full and Just Sum of thurteen thousand five hundred dollars according to the true Intent and meaning of the said Bond afterwards and of these presents together with lawfull Interest from the date hereof then this deed of Bargain and Sale and all and Every Clause article and thing therein Contained shall cease determine and be utterly void and of none Effect any thing herein Contained to the contrary thereof in any wise notwithstanding and it is hereby declared by and between the said parties and the said Jully H Sullivan his heirs Executors administrators and assigns by these presents that if default shall happen to be made of or in payment of the said Sum of thurteen thousand five hundred dollars as aforesaid according to the true Intent and meaning of the said Bond that then and in such case it shall and may be lawfull to and for the said John Robinson and James K Robinson their Executors administrators attorneys or agents from time to time and at all times hereafter peaceably and quietly to Enter into any or all the Messuages lands or tenements of the said Jully H Sullivan and to take the said Negro Slaves into their custody and possession and the same to hold and detain to their own use and behoof as their own proper Goods and Chattels from thenceforth and forever or the same to sell and dispose of at Will and pleasure returning the overplus if any should happen to be after paying the said Sum of thurteen thousand Eight hundred dollars unto the said John Robinson and James K Robinson their Executors administrators or assigns in Witness wherefore I the said Jully H Sullivan have hereunto set my hand and seal this fourth day of March in the year of our Lord one thousand Eight hundred and thirty four and of the sovereignty and Independence of the united States of America the fifty Eighth
