

224 The State of South Carolina Know all men by these presents that I Waddy Thompson Senr of the district of Greenville and State aforesaid for and in consideration of the Sum of three thousand five hundred dollars to me in hand paid by Gandy Walker Esquire the Receipt Whereof is hereby acknowledged Have Granted Bargained Sold released and conveyed and by these presents do Grant Bargain Sell release and convey unto the Said Gandy Walker Esquire his heirs and assigns forever the following tracts or pieces of land lying and being in the district of Greenville on the Waters of reedy River the first tract Beginning at a stake on the West Side of the augusta Road Running thence So 44 W 4 chains and 70 links to a black oak thence S 78 W 14 ch 75 links to a B. O X thence S 18 E 25 ch 13 links to a B. O Sapling thence due East 7 ch 75 links to a post oak corner thence N 10 E 9 ch to a stump in John Bales Field thence S 62 W 1 ch 50 links to a stake by Said Bales fence thence N 77 W 9 ch to a black oak stump thence N 62 E 5 ch 37 links to a stake by a B. O sapling on the augusta Road and thence up the said road N 2 W 11 chains to the Beginning thirty one and three fourth acres more or less ~~also~~ one other tract Beginning at a small red oak corner and running N 18 W 34.50 chains to a B.
